

# 2019 LITTLE MISS & MR PAGEANT

Sunday, September 1, 2019, at 3:30 pm

## RULES AND REGULATIONS

1. Contestants **MUST** register as a Couple.
2. Contestants must be 4 before June 30, 2019 and cannot be 7 before June 30, 2019.
3. Each contestant must be a Kentucky resident.
4. Contestants must appear in regular street clothes. (**NO long dresses, tuxedos, or parts of tuxedos**).
5. Contestants must attend pageant and compete as a couple on Sunday, September 1, 2019 at 3:30 on the entertainment stage. **Contestants must be at the Fairgrounds by 3:00 pm.**
6. Any contestant that has competed at the professional level will be considered ineligible for this pageant. Professional level is defined as follows: Any contestant that has performed or competed for monetary gain in anything other than an amateur contest.
7. Not eligible to enter if you have previously won another county fair pageant in the state of Kentucky in 2019 in this age group.
8. **Judge's Decision is FINAL.** Judging will be based on appearance, poise, and personality.
9. The Pageant Committee reserves the right to dismiss at any time any contestant who does not show the proper amount of cooperation and courtesy to Committee members, consultants, judges, or fellow contestants. Any conduct deemed unbecoming by the Pageant Committee will automatically disqualify a contestant.
10. One couple will be chosen Little Miss & Mr. Alexandria Fair & one couple will be chosen as runner-ups.
11. Winners must agree to participate in assigned fair activities 2019 and 2020.
12. Winners agree to represent the Alexandria Fair at the 2020 State Fair Pageant.
13. **CASH ONLY Non-refundable Entry fee of \$30 must accompany the entry form. (\$15 each).**
14. **Contest is limited to the FIRST 25 couples PAID registration.**
15. **Entries will be taken Sunday, August 18<sup>th</sup> 1-3 pm and Thursday August 22<sup>nd</sup> 7-8 pm at the Alexandria Fairgrounds Dining Hall. No entries will be taken after 8 pm on August 22<sup>nd</sup>.**
17. No contestant can be in more than one pageant at the Alexandria Fair in the same year.

**NOTE: NO mail-in registration will be accepted.**

### 17. Contestants and Parents/Guardians must agree to the following:

I (we) hold harmless the Campbell County Agricultural Society (Alexandria Fair & Horse Show), their stockholders, officers, directors, associate members, junior members, volunteers, agents, servants and employees against all claims or demands arising or resulting from my participation in the Pageant. Without limitations, I (we) hold them harmless for accidents, damages to or loss of personal property, equipment and/or clothing, bodily injury, sickness, mental anguish or death from any cause in conjunction with the Pageant.

In addition, I (we) agree all photographs, film, videotape and other publicity materials resulting from my association with and participation in the Pageant will become the property of the Campbell County Agricultural Society (Alexandria Fair & Horse Show) to be used as they see fit and without compensation to me.
